COMMISSION MEETINGS BEING PLANNED

The Commission is currently planning for meetings that will be held in Heidelberg, Germany, August 17 - 19, 1994, and in Prague, Czech Republic, the following week.

The theme for the Heidelberg symposium is "Beyond Borders: The Gender Implications of Multistate Economic Policies." It will explore the differential implications for women and men of new multistate policies, especially the Single European Market and the North American Free Trade Agreement. The Commission is especially interested in developing a comparative analysis of likely regional shifts in employment opportunities and in modifications of social policies (such as gender equity in pensions, maternity/family leave rights) that affect the quality of women's lives as states start to adjust to and resist demands of the new policies. Studies that address the diversity of women by ethnicity, age, marital status, local, national, and international comparative scales are welcome. At the Prague Regional IGU Congress, the Commission plans a joint symposium with the World Political Map and Public Administration Commissions on "The Politics of International

Migration and Citizenship." We are interested in papers that deal with the specific experiences of women as migrants and refugees and the gendered nature of citizenship, recognizing the importance of these issues at local, regional, national, and suprastate scales, particularly in relation to changing political structures in Europe and the rising incidence of xenophobia and racism. The Commission's participation in this joint program is being planned by Eleonore Koffman, Nottingham Trent University, Clifton Lane, Nottingham, NGH 8NS, England, FAX 44-602-486632 by August 15, 1993. The Commission is also interested in organizing additional sessions during the Prague program on gender themes, particularly around issues of women and political change and women and environmental change. BARCELONA MEETING TO FOCUS ON SOUTHERN EUROPE

The Commission will co-sponsor the Erasmus network meeting on "Women's work, Women's Employment, and Everyday Life: Focus on Southern Europe" to be held at the Autonomous University of Barcelona, June 18-28, 1993. Organizing Committee for the meeting are Professors Gemma Canoves, Ma. Dolors Garcia Ramon, Montserrat Solsona, and Antoni Tulla. Interest in the program is high, with

100 participants expected. Cooperating Erasmus universities include Amsterdam, Autonomous of Barcelona, Durham, National Technical, Athens, Roskilde, and Sheffield. Speakers and student representatives from these institutions will be joined by others from Portugal, France, Canada, Italy, the UK, USA, and elsewhere in Spain.

The program will place the southern European experience in an international context both substantively and methodologically. Sessions will be devoted to urban and rural issues and case studies on Portugal, France, Italy, and Spain, together with a detailed look at Catalonia, including local field study.

1995 IGU REGIONAL MEETING SCHEDULED FOR CUBA

CONGRATULATIONS

Joos Droogleever Fortuijn and Lia Karstens have recently completed their doctorates at the University of Amsterdam. In the Netherlands, this degree is awarded after some years of professional activity rather than at the beginning of an academic career. Both dissertations (see PUBLICATIONS section of the newsletter) have been issued in book form and attracted considerable press and media attention.

Linda Peake received tenure at York University in Canada in 1992. She has also received a large grant from the Social Sciences and Humanities Research Council for a project "An Investigation of Household Livelihood Strategies of Guyanese Women in Low Income Households" which includes attention to the migration of Guyanese women to Toronto as well as their lives in Guyana.

Sarah Radcliffe and Sally Westwood (UK) have received funding from the Economic and Social Research Council for a project "Remaking the Nation: The Social Geography of Nationalism in Ecuador," which will examine nationalisms, nationhood, and national identity in relation to ethnic diversity, class, and gender divisions in the context of locality.

Susan Hanson (USA) received honors from the Association of American Geographers at its annual meeting in Atlanta in April, 1993. Honors are the Association's highest award. Susan's contributions to feminist geography were recognized, as well as her editorial services to the Annals, Economic Geography, and The Professional Geographer, and her recent presidency of the Association.

Women's Studies Forum published by the Korean Women's Development Institute contains a variety of articles of potential interest to geographers, particularly given the limited amount of feminist work being published by East Asian geographers. Recent issues have contained articles on determinants female labor force participation in Korea; child care policies in low-income urban areas; home-based work in Korea; female employment in the food-service industry; Korean rural women's labor; and homemaker services for the aged. Cendoc Mujer, (Centro de Documentacion Sobre la Mujer), Av. Mcal. La Mar 170, Lima, Peru has developed an information package on "The grassroots women's movement as an answer to crisis" drawing on their files of testimonies and newspaper clippings. The package deals with the activities of over 50,000 women in 40 districts of Lima who participate in such activities as communal kitchens and milk distribution. It gives information about the organizations, the development of women's consciousness and leadership, and the situations they confront from terrorist groups. The package costs \$US33.00 mailed to the USA, Canada, or Europe.

Yukiko Bedford (Japan) has organized a Gender and Geography Study group in cooperation with a woman graduate student of Osaka City University.

Two new projects underway at the University of Pretoria are on black professional women in the urban environment of Garankuwa, Bophuthatswana by Maria Moate for her master's thesis, and a study of the impact of industrialization in the same community by Rosina Phalatdsi.

Yoga Rasanayagam (Sri Lanka) presented a paper on "Recent State Policies and Autonomy of Women in Sri Lanka" at a seminar organized by the Women's Wing of Public Services International and also gave a paper on "Coping Strategies and Tamil Women Refugees in Colombo" at the August meeting of Sri Lanka's National Geography Conference. She is currently teaching a two-part women and development course (theory and Sri Lankan cases).

Janet Momsen (USA), Janice Monk (USA), Gudrun Olafsdottir (Iceland), and Vidya Samarasinghe (Sri Lanka/USA) participated in the International Interdisciplinary Women's Studies in San Jose, Costa Rica in February, 1993. The next meeting will be held in Adelaide, Australia in 1996. At that time, the Commission would like to see sessions organized with a geographical focus. Australian, New Zealand, and Asian members please take special note!

A colloquium series in the Department of Geography, University of Zurich in the Fall semester, 1992-1993 addressed theoretical issues of feminist geography as well as case studies of women in education, part-time employment, and planning positions.

PAST AND FORTHCOMING CONFERENCES

The 8th Historical Geography Conference held in Vancouver, August, 1992, included a number of well-attended papers on gender themes. Foremost was a special session organized by Alison Blunt (Canada) and Gillian Rose (UK) which included papers by Jeanne Kay (Canada) on female archetypes in 19th century North America; David Smith and Judy Barrett-Litoff (USA) on U.S. women's use of space in World War II; and papers on 19th century women travel writers by Alison Blunt and Cheryl McEwan (UK) which brought together theoretical issues of gender, class, race, and space. Outside this session, feminist/gender papers

were also given by Jenny Robertson (South Africa) on post-colonial critiques and Iain Robertson (UK) on women and social protest in 19th Scotland. The next Historical Geography Conference will be held in Perth, Australia in 1994 and offers scope for presentations in this expanding area of feminist geography.

The Sexuality and Space Network (UK) held a meeting in September, 1992 which included a number of papers on lesbian and gay geographies. A full report of the conference prepared by Gillian Rose will appear in Area.

The National Conference of German Women Geographers, held in Gottingen, November 26-29. 1992, attracted 26 participants from Frankfurt. Trier, Oldenburg, Berlin, Gottingen and Halle. A presentation by Heike Klamp (Frankfurt) drew on her master's thesis on "Women's Ways, Men's Ways: Spatial Mobility as Necessity," which studies daily travel in a Frankfurt suburb. Ulrike Meyer-Hanschen (Berlin) drew on her work with a selfhelp group for prostitutes in Bangkok presentation, "Prostitution for Tourists in Thailand." Sociologist Daniela de Ridder spoke on "Safety in the City," using the campus area at the University of Gottingen as a case study to identify areas of danger for women. The next meeting of the group will take place in Berlin, June 18-20, 1993 following up on these topics and adding a discussion of feminist criticism of physical geography. Two meetings including participation by German feminist geographers are the Workshop on Regional Sciences, Tirolia, April 21-24, 1993, where attention was directed to ecofeminism, and the upcoming 49th German Geographers meeting in Bochum, October 3-8, 1993.

Gender studies are gaining increasing attention in South African geography. The first session devoted to the theme is planned for the national geography conference in July. In addition, Linda McDowell will be a featured speaker. Joan Fairhurst (Pretoria) has also organized a panel for the meeting of the

African Studies Association of Southern Africa which will include presentations by Agnes Musyoki (Kenya) on women and development, Steven Johnson (Bophuthatswana) on women and environment, Maria Moate and Joan Fairhurst (S. Africa) on the daily lives of women living on the rural urban fringe in Nooitgedacht, Bophuthatswana, and Milla McLachlan and Janine Erasmus of the Development Bank of S. Africa on initiatives with regard to gender issues.

The Women and Geography Study Group of the Institute for British Geographers pursued the theme "Effective Communication: Reading, Writing, and Authority" at the Annual Meeting in January, 1993. Presentations were given by Marcus Doel, Liz Bondi, and Sarah Radcliffe dealing with post-modernist, psychoanalytic, and post-colonialist approaches. A workshop on (Representing) Postcolonial Women: Authority, Difference, and Feminisms" followed.

Feminist geography was highly visible at the Annual Meeting of the Association of American Geographers in Atlanta, April 6-10, 1993, with papers in virtually all the time slots, and sometimes simultaneously. Themes in sessions organized by the Specialty Group on Women (GPOW) and the Committee on the Status of Women in Geography (some co-sponsored with other groups) ranged from methodology (critical perspectives on women in the field), to pedagogy (approaches to teaching that will motivate and improve performance by girls and minority students in high school geography), to an array of theoretical and empirical papers in cultural geography. urban geography, comparative international feminist geography (including an international group of panelists-Hae Un Rii (Korea) Joos Fortuijn (Netherlands), Linda McDowell (UK), Melissa Gilbert (UK)), gay and lesbian studies, social (in)justice, historical geography, Latin American women, and graduate student and faculty concerns. A group of undergraduates from Vassar College gave excellent presentations on their research, and numerous other papers were included in sessions organized by other groups or submitted independently. A significant number of people attended a GPOW-sponsored breakfast meeting, a lunch-discussion, and the group's early evening

business meeting attracted about 70-80 geographers. Perhaps the best way to capture the presence of feminist geography at this meeting is to note that only one other area (the trendy Geographic Information Systems) appeared in the index of the Abstracts volume with greater frequency than the combined entries "women" and "gender!"
